An update of the Child Safety Procedures was presented to the meeting, which included the signing of the acknowledgement of the Child Safety policy which will be uploaded to the BHRDCA website.

Andrew Grainger (Bulleen Templestowe) raised a concern regarding the process of promotion/relegation and requested more transparency to the competition.

We expect the dates to be released at the earliest, and once received the clubs will be advised.

On the verge of signing a new two year contract with Kookaburra, with slight increase compared to the current agreement.

The 2021/22 Season Launch will be held on Wednesday the 6<sup>th</sup> October at Mitcham Cricket Club.

The 2021/22 Senior Presentation night will be held on Friday the 8<sup>th</sup> April at the Mulgrave Country Club.

All City of Whitehorse grounds will be available for season 2021/22, no ground works are scheduled. We have had discussions with the City Of Whitehorse with regarding to Bennettswood Reserve North, which we expect to be available by season 2022/23.

Peter Rosenthal provided the meeting with Peter White's latest health conditions, and suggested clubs drop him a line to pass on their best wishes.
